

The Grail Movement - much darkness in the light of truth!

Thousands of readers and adherents of Abd-ru-shin's Grail Message "In the Light of Truth" have been excluded from the spiritually paralyzed and divided "International Grail Movement" in recent decades; for example because they pointed out undesirable developments and/or criticized the leadership of the >International Grail Movement<. However, even if they developed activities on the basis of the Grail Message in order to help shape a spiritually lively Grail Movement, but did not subordinate themselves to the "International Grail Movement". They had overlooked the fact that the International Grail Movement and the Grail Message Foundation claim the interpretative sovereignty and commercial exploitation of Abd-ru-shin's Grail Message "In the Light of Truth" without any legal basis and, if necessary, also enforce it harshly. Those who did not accept this were denied access to the Temple of the Grail Movement on Vomperberg and were denied participation in the high celebrations.

Not infrequently, the committed confessors of the Grail Message were completely in despair for the rest of their lives and were avoided like lepers by those who - let's put it in plain German - kept their mouths shut in order to be able to continue to take part in the devotions and celebrations and to be in blind following in the hierarchy of the strictly organized International Grail Movement.

Although Abd-ru-shin's Grail Message is aimed directly at the individual, the 'International Grail Movement', interested in power and donations, pushed itself between the Grail Message and its believers. Those who pretended to ensure that the Grail Message was spread in the spirit of the author did what Abd-ru-shin accused the churches of in his lecture "Resurrection Morning":

„ ... The churches were looking for adherents, wealth and power. For this purpose, no one was allowed to know that he could find his way into the kingdom of his God all by himself, without the help of the church! It must not occur to him that God does not need a church between himself and his creatures, which he also created without a church."

But this lecture was simply removed from the Grail Message after Abd-ru-shin's death! As well as other lectures that could throw an unpleasant light on the highly-acclaimed failures. Even if these events happened decades ago, nothing has changed in this tragic development of the organized Grail Movement to this day. Because the hypocrites clinging to power only called disciples who continued in the same non-spirit and did not touch the halo of their patrons.

Mr. Alexander Bernhardt, seriously ill, resigned, overwhelmed by his task and only nominally the leader of the "International Grail Movement", recognized this development early on and repeatedly warned:

*"The darkness strives to penetrate into the core of the light events,
because from there it can achieve the most!"*

But by then it was already too late to set the course in the right direction. Goodbye to the Grail Message!

The mockery of the Grail Message and its author in the temple of the Grail Movement on Vomperberg

A >Annunciation< that was in blatant contradiction to the Grail Message, allegedly from the primal spiritual level at the celebration on August 17, 1948 in the temple on Vomperberg on the occasion of Mrs. Maria Bernhardt's birthday, was more or less the >canonization< of the author's wife, who died in 1941 of the Grail Message and her daughter Irmgard Bernhardt. This "announcement" dictated by obviously dark forces was a mockery of the Grail Message and its author in the temple of the Grail Movement on Vomperberg! The goal of dark forces had been reached; the development of the earthly Grail Movement was firmly in their hands! The Grail Message was only a useful advertisement!

The blind allegiance of the >cross bearers< and confessors of the Grail Message demanded in this primitive copy of a genuine >Annunciation< with the introductory words "Hear the words that I may announce to you from the omnipotence of Lord Parzival-Immanuel:" was tailor-made for the financial interests of the wife of the author of the Grail Message and her daughter Irmgard Bernhardt. The loyal managers of the "International Grail Movement" who were called to be "Gold Crossers" and "Disciples" followed the "Annunciation" without recognizing this work of darkness as such - or maybe they did? Where doubts arose, they were pushed aside. Through this announcement, they could continue to enjoy their personal power in leading positions of the "International Grail Movement" and expand into well-functioning cliques and family clans with Stasi methods - but only as long as they were diligent enough to transfer a large part of the donations and bequests from inheritances to the "Grail Administration Vomperberg". < - while thousands of alleged adherents of the Grail Message looked the other way, didn't listen, kept silent and donated!

On the other hand, they supposedly belonged to the "elite of humanity" who - like me - were allowed to take part in Grail celebrations as the chosen ones in tails, white pigskin gloves, black patent leather shoes and a top hat; and not just as a spectator like in Bayreuth. Who is going to ask questions?

With the founding of the >International Grail Movement<, for which there is absolutely no need according to the Grail Message, the power that people have access to through the Grail Message began to flow down the wrong channels. But that has always been the case, in principle, when organizations were established between God and man. Her main goal has always been to increase her own power; the

advanced ideal goals are sometimes painlessly sacrificed! The >International Grail Movement< is not an exception in this regard, but a prime example.

Many adherents of the Grail Message have so far been reluctant to speak openly about their soul troubles, which have arisen because the behavior of some leaders in the various, quarreling branches of the Grail Movement contradicts what the author of the Grail Message demands of those who pretend to act on his behalf. But the accusation directed at the members of the Grail Movement of a mentally sluggish "dumb mentality" is also justified, because they allowed and promoted behavior by their "leaders" that was not oriented towards the Grail Message.



Of course, some cross-bearers dared cautious criticism again and again. But the Apostle Herbert Vollmann, who for decades with great sophistication and an underdeveloped love of truth led the so-called >Grail Administration Vomperberg< and in reality also the >International Grail Movement<, could no longer be reached by objective criticism on the basis of the Grail Message. Due to his position within the Bernhardt family, Herr Vollmann was the greatest weak link in the Grail Movement that the Darkness could exploit. He hindered and prevented all the help prepared by the light! Like his current successor, the self-appointed "office-bearer of the leadership of the Grail on Earth" Siegfried Bernhardt and like Jürgen Sprick, the mentally unstable head of the "Sprick Group" in his various functions as long-term board member. Anyone who wanted to get involved in the International Grail Movement, assuming that the Grail Message of Abd-ru-shin was something like a guiding principle there, sooner or later woke up sobered up and soon stopped being surprised at how many of the leaders in the Grail Movement have become mentally ill, who could only continue to participate in the hypocritical theater game with psychotropic drugs and long-term psychiatric care.

In order to assert the rule of dark forces on the Vomperberg and in the branched >International Grail Movement< over many decades against critical readers of the Grail Message, the spirit of the Grail Message was ignored, betrayed and denied by the leaders of the Grail Movement and their followers! Not infrequently with the pressure of the most reprehensible psychological blackmail, which is in no way inferior to medieval inquisition and torture! According to the motto: "The end justifies the means!" many of the leading called ones, disciples and apostles of the "International Grail Movement" put their preservation of power in the foreground and the Grail Message aside! In any case, repelling and suppressing critics in their own ranks who called for the Grail Message to be the basis for the development of the Grail Movement, as well as successful donation management, had long since become the main task of the loyal "leaders" in the International Grail Movement. Anyone who was looking for the promotion of spiritual development through the Grail Movement would have been better off going into the desert!

The donations of those who wanted to support the realization and implementation of the goals of the author of the Grail Message >In the Light of Truth< were misused and privatized by some executives! The obscure donation practice - in which I was involved for a while as Irmgard Bernhardt's private secretary - was used by insiders and members of the Bernhardt family for mutual blackmail and personal enrichment. The so-called "Grail Administration" on Vomperberg in no way fulfilled a control function in this regard - on the contrary; behind the entrance door to the Grail administration on Vomperberg, the donations disappeared into a >black hole<! Uncomfortable questions about the whereabouts of the millions - and many millions are at stake - often resulted in exclusion from the "International Grail Movement" and thus a ban on participation in the prayers and celebrations.

Long-serving leaders of Grail circles and national organizations of the "International Grail Movement" were relieved of their offices if they refused to write confidential monthly reports Stasi-style, which had to report specifically on members of the Grail Movement who were critical of the Grail administration dem Vomperberg and the Bernhardt family and questioned the use of the donations.

Ever since Irmgard Bernhardt left her entire estate to her adoptive daughter Claudia-Maria Bernhardt in her will in 1990 - which came about almost exclusively through donations and estates from the confessors of the Grail Message and through their decades of work on the construction of the Grail settlement in Vomperberg - hardly any questions have been asked about the use of the donations ; you know it anyway!

The >Grail Movement<, which is protected by trademark law, is still a division of the >Bernhardt Company, Vomperberg< owned by the Siegfried Bernhardt family.

The management of the "Grail Administration Vomperberg" was always in the hands of the author of the Grail Message or his family. Since 1990, the so-called >Grail administration of Vomperberg< has belonged to the Siegfried Bernhardt family through questionable events - but legally secured; as can be read on the Internet (as of November 19, 2022) at <http://www.gralswerk.org/>: "The Vomperberg Grail Administration belongs to Bernhardt. The employees working in all areas are employees of the Bernhardt company." In order to safeguard his business interests, Siegfried Bernhardt (née Holzäpfel) tried to forbid the disciple Jürgen Sprick to use the term >International Grail Movement< for the so-called >Sprick Group< in court proceedings, "because this would endanger his own business interests". . The plaintiff (Siegfried Bernhardt) had the name "Gralsbewegung" protected as a trademark. The defendant Jürgen Sprick violated the provisions of the law against unfair competition (UWG).

The Grail Movement had become a plaything for the economic interests of highly qualified 'disciples'!

The disciple Jürgen Sprick, who has been acting in the Grail Movement for decades in the spirit of the Apostle Herbert Vollmann, has been leading the numerically largest branch of the 'International Grail Movement' for many years, the so-called 'Sprick Group'. For many years, Jürgen Sprick was responsible for securing and promoting the personality cult controlled by Vomperberg in the sense of tailor-made proclamation. To this end, his predecessors had no hesitation in promoting the work In the Light of Truth - Grail Message of the Last Hand with the incorrect claim that the lectures published in it were written between 1923 and 1938. The fact is, however, that shortly before his death in 1940 and 1941, Abd-ru-shin made significant corrections and changes to the original version created between 1923 and 1938, which must be of fundamental importance for the development of the Grail Movement. As will be shown below, for example with the lecture: >Let there be light!<.

The Grail Message Foundation must therefore be accused of the fact that Abd-ru-shin, which is important for the readers of the Grail Message and the development of the Grail Movement, has recognized his original confession: "It's I, Imanuel" as a mistake and corrected it, intentionally to have kept secret. Those responsible at the Grail Message Foundation thus followed the strategy prescribed by Vomperberg of concealing the error corrected by Abd-ru-shin shortly before his death. As a result, the Grail Movement still predominantly holds the opinion that the Son of God Imanuel was incarnated in Abd-ru-shin, the author of the Grail Message; Abd-ru-shin and

Immanuel were, so to speak, identical. The adherence to Abd-ru-shin's error - despite his correction - was the indispensable basis for the maintenance of the personality cult and its continuation according to the outrageous proclamation at the celebration on August 17, 1948 in the temple on Vomperberg on the occasion of Mrs. Maria Bernhardt's birthday. The Grail Message Foundation is still the henchman of dark forces and significantly involved in the decade-long undesirable development in the Grail Movement! The disciple Jürgen Sprick, who worked for many years as a board member of the Grail Message Foundation and then as a board member of the >International Grail Movement<, is primarily responsible for this!

Was extortion involved in broadcasting the 'guidance of the grail on earth'?

There is no denying that Siegfried Bernhardt has a high degree of sophistication to achieve his goals. But without the active support of his then wife Claudia-Maria Bernhardt, the adopted daughter of Irmingard Bernhardt and her sole heir, Siegfried Bernhardt would not have succeeded in the greatest swindle of his life:

"I hereby transfer the entire leadership of the Grail on earth, i.e. both the spiritual and the earthly leadership in all countries of the world, to Mr. Siegfried Bernhardt, born on July 1st, 1955 in Calw (FRG)."

The question naturally arises - not just meant ironically - as to whether Parzival, who is called the "King of the Grail" in the Grail Movement and according to the Grail Message, agreed that Irmingard Bernhardt took away the "leadership of the Grail on Earth" from him and her son-in-law transmits. But if you are looking for the causes of the spiritual torpor of the Grail Movement, you must also include this insane act by Irmingard Bernhardt. She should have read the Grail Message more often!

In connection with Irmingard Bernhardt transferring the 'leadership of the Grail on Earth' to Siegfried Bernhardt, many more questions would have to be asked, but then not much would remain of the 'Grail Movement on Earth'! Because if you take the Grail Message as a basis, the undoubtedly very practical transmission of the "guidance of the Grail on Earth" within the family is further proof of the relaxed hand with which the Bernhardt family assumed their spiritual responsibility. A close colleague of Irmingard Bernhardt for many years, who had known all internal and family matters and sloppiness for decades, refused to continue working for Irmingard Bernhardt in connection with the transfer of the >guidance of the Grail on Earth< to Siegfried Bernhardt. She justified her resignation with the words: "For me there is now only the Grail Message. Everything else is big theatre, intrigues, blackmail, lies, deception, threats, exploitation and fraud." For her, Claudia-Maria Bernhardt was the drop that "broke the camel's back": "Claudia is blackmailing Miss Irmingard! She's worse than her mother." Under false pretenses, the sole heir had been taken from Irmingard Bernhardt as the only adopted daughter at the time.

In the meantime, Siegfried Bernhardt officially empowered himself to be the "office-bearer of the leadership of the Grail on earth"; one might ask, why not immediately 'Representative of Parzival on Earth'? He ruthlessly asserted his own interests in the internal power struggles of the Grail Movement, thereby causing the greatest damage to the cause of the Grail. Nevertheless, he has held power over the "International Grail Movement" for a surprisingly long time, including the dubious appropriation of the Grail settlement in Vomperberg and other significant assets at home and abroad. The bad reputation he has acquired in the process - inheritance smugglers and imposters are the nicest terms - enough blind and fanatical 'cross bearers' still make up for it with their 'homages'.

While some peoples are chasing their corrupt dictators out of the palace, many 'cross-bearers' bow in reverence to their 'leader of the Grail on earth', who came to power over the 'holy mountain' through lies and deceit!

Irmingard Bernhardt, who commissioned him on May 8, 1990 to "guide the Grail on Earth", would turn in her grave if she found out what damage her son-in-law Siegfried Bernhardt, whom she internally referred to as >Lapp<, caused due to her authorization has done in the Grail Movement. According to the author's announcement, this writing should "offer the cross-bearers - also those who will be added later - a factual basis for their own examination", but it should primarily help to show the faded and darkened halo of the highest calling in the Grail Movement and opponents of Siegfried Bernhardt to brush up! This writing in the tried-and-tested style of the top manager of the International Grail Movement, Jürgen Sprick, may just about pass legally, but a truth-bound >Association for the Realization of the Grail Knowledge of Abd-ru-shin< should have nothing to do with this falsification of history! However, this writing may one day be useful as a script for a tragic comedy in Bayreuth! Or maybe just for a smear show!

Why does the "official of the leadership of the Grail on earth" need a private foundation from his family in Switzerland?

In Switzerland, the Bernhardt family has, among other things, the private >Foundation Gralswerk<. According to the official documents, Siegfried Bernhardt serves as President of the Board of Trustees, his daughter Elisabeth Bernhardt is a member of the Board of Trustees and Siegfried Bernhardt's current wife Diane Catherine Bernhardt is also a member of the Board of Trustees. Officially it says: "The purpose of the foundation is the promotion of religion, education, upbringing, art, culture and international understanding on the basis of the ideas of the work In the light of truth Grail Message by Abd-ru-shin (Oskar Ernst Bernhardt) as well as the

pursuit of charitable purposes." How the purpose of the statute "promoting religion on the basis of the Grail Message" can be practically implemented without violating Abd-ru-shin's clear statement: "I don't want to found a new religion" is the higher wisdom of Irmingard Bernhardt with the >Leading the Grail on Earth< is left to the commissioned President of the Board of Trustees. But that's no longer the point. Especially since the foundation is apparently intended to serve the private financial interests of the Bernhardt family more than the Grail Movement. Otherwise the board of trustees would have been filled with personalities who enjoy the trust of the international Grail Movement.

Appearance and reality of an honorable family

The spiritual and earthly development of the Grail Movement has long since ceased to be hindered by politically or religiously motivated organizations and individuals, as it was in Abd-ru-shin's time, but misguided by the autocratic and greedy alleged "leadership of the Grail on Earth" which not oriented towards the Grail Message but, above all, professionally pursues the increase and safeguarding of the family fortune. After all, you learn from the past. Because when Irmingard Bernhardt left her entire estate to her adoptive daughter Claudia-Maria Bernhardt - which came about almost exclusively through donations and estates from the confessors of the Grail Message and through their decades of work on the construction of the Grail settlement in Vomperberg - she had neglected to secure the family property for years. Her careless handling of donations, among other things, made her vulnerable to blackmail within her family and millions of donations ended up in the pockets of people close to her, blackmailers, leaders of Grail circles and asset managers.

The "International Grail Movement" has long been a sect with a strong personality cult; initiated and used for personal enrichment by the descendants of the author of the Grail Message - to this day! The assets in the form of sums in the millions, real estate, buildings, securities, company shares, etc., which were actually intended for a Grail Movement in the sense of the author of the Grail Message through donations and inheritances, etc., are through lies and deceit - but legally secured - in the private possession of the Bernhardt family or their foundation and their companies.

Results from the implementation and application of the valuable scientific principles that the author of the Grail Message "In the Light of Truth" left behind in his work must be looked for with a magnifying glass in the International Grail Movement almost a hundred years after the publication of the first parts of the Grail Message . But this task was apparently never in the foreground!

Abd-ru-shin writes in his Grail Message that entire books can arise from each of his lectures by those who are called to do so. Many adherents of the Grail Message who not only wrote books on the basis of the knowledge accessible to them through the

Grail Message, but also integrated this knowledge into their professional activities, in research, science, art, business and society, were excluded from the Grail Movement if they refused to subordinate the companies, institutes, foundations and organizations they founded for the purpose of implementing the knowledge from the Grail Message to those who rule the organized and supposedly "official" Grail Movement. The Grail Administration Vomperberg and the Grail Message Foundation have taken action against their alleged authority and authority to interpret the Grail Message "In the light of truth" by Abd-ru-shin on the basis of a repeatedly claimed, but legally non-existent copyright to the Grail Message, which come close to medieval torture of the Church. Even decades after the clear decision of the Supreme Court of the Republic of Brazil. (Source: legal dispute over the copyright of the Grail Message)

In the last few decades, framework conditions have emerged in the International Grail Movement that prevent its members from developing spiritually and on earth as Abd-ru-shin demands in his Grail Message >In the Light of Truth<. And not only for the members of the Grail Movement, but also for every searching reader of the Grail Message, the current organizations of the Grail Movement have become an obstacle. People who are looking for spiritual help are attracted by the Grail Message and unsuspectingly end up in the organizational structures of the International Grail Movement, in which their spiritual development and activity is misused in predetermined channels.

The author of the Grail Message "In the Light of Truth" originally had neither the intention of founding a sect or a religion nor of leading one.

Abd-ru-shin repeatedly emphasized that his Grail Message is aimed at the individual. Abd-ru-shin said about his goal in 1936:

"My goal is spiritual! But I bring no new religion, I do not want to found a new church, just as little any sect, but I give in all simplicity a clear picture of the automatic work of creation, which carries the will of God, from which man can clearly recognize which paths are good for him are."

In line with this guiding principle, Abd ru shin wanted his message to be the focus, but he never wanted to draw attention to himself as the center of the Grail Doctrine. He rejected personality cults. He asked his readers clearly and unequivocally to pay attention "not to the bringer, but to the word". And yet he literally let himself be idolized. At first he was addressed as Master, also as Master of the Order. Later the term >Lord< was introduced and it became >LORD<. He saw himself as IMANUEL. Grail Knights, Apostles, Disciples, Golden Crosses and Silver Crosses were sealed

and appointed in religious ceremonies. His wife and their adult children were venerated as saints by his followers. He put up with all of this. This laid the foundation stone for an erroneous development, as is known from the history of all religions, orders and sects at all times. This lucrative cult of personality is kept alive to this day by the "leader of the Grail on Earth" and his followers, as well as the "International Grail Movement" led by the disciple Jürgen Sprick.

Immanuel personally or a radiation link?

In the Grail Movement the opinion is predominantly held that the Son of God Imanuel was incarnated in Abd-ru-shin, the author of the Grail Message; Abd-ru-shin and Imanuel were, so to speak, identical. Abd-ru-shin himself made a significant

contribution to this assumption. Be it through statements in his Grail Message from 1931 (page 567) or the echoes from 1934 (page 54). Not least because Abd-ru-shin spoke the words his followers longed for: "It's me! Imanuel". Yet these words have caused nagging doubts in some of his apostles, disciples, and other highly called ones. Because in contradiction to this self-confidence are statements concerning Imanuel in the Grail Message "In the light of truth" by Abd-ru-shin himself, according to which no human spirit would endure the light power in the vicinity of Imanuel. A personal presence of Imanuel on earth would lead to the immediate annihilation of mankind. For this reason alone, Imanuel cannot have been incarnated in Abd-ru-shin or Oskar-Ernst Bernhardt.

During an extensive conversation I had with Irmingard Bernhardt on this subject, she made it absolutely clear: "It's always about radiated connections!" Also about herself.



Abd-ru-shin retracted his confession "It's I, Imanuel" a few years later and documented this shortly before his death on earth by changing his >Grail Message of the Last Hand<; like this, for example, in the lecture: LET THERE BE LIGHT! is recognizable. While it was still said in 1934:

"Abdrushin was therefore Parzival and therefore also Imanuel through the continued direct radiation connection,"

can be read in later editions in the same lecture:

"Abd-ru-shin was therefore Parzival through the continued direct radiation connection".

Although Abd-ru-shin speaks here very clearly only of a radiation connection, the error that Abd-ru-shin himself recognized and corrected was still adhered to. (<https://www.die-gralsbewegung.org/abd-ru-shin-s-leben-und-wirk/>) Probably not least because it increases the market value of a sect in its competitive struggle!

And so an 'International Grail Movement' came into being, whose self-image and organizational structure are based on a personality cult that refers to Abd-ru-shin's later retracted words: "It's I, Imanuel". The loyal 'leaders' of the 'International Grail Movement' use the power given to them by this confession to this day on the grounds that they were installed by a leadership called to do so, who was appointed in the hierarchy of the Grail Movement by Abd-ru-shin, the son of God Imanuel was used. Anyone who questioned the autocratic power of the higher management level was excluded from the "International Grail Movement" and henceforth avoided like the plague by the obedient members of the "International Grail Movement". Those who nevertheless maintained contact with the "excluded" were also threatened with their exclusion from the International Grail Movement, which was then often carried out!

Conclusion: The >International Grail Movement< is a sect like many others! Arose from hunger for power and greed for money, with lies and deceit, Stasi methods and blackmail!

When an organization like the >International Grail Movement< claims to "represent all people, regardless of language, race or nation, who profess the ideas of the Grail Message >In the Light of Truth<", this is not in spirit of the Grail Message, she only pretends to fulfill a task in the sense of the author of the Grail Message!

This divided, unsuccessful and mentally paralyzed organization is not a Grail movement! It misuses Abd-ru-shin's Grail Message "In the Light of Truth" and the designation "International Grail Movement" only as a figurehead for its own commercial goals!

In order to prevent misunderstandings, it should be said that this Internet forum is not intended to provide seekers with answers to ideological questions in the sense of the Grail Message. Abd-ru-shin's Grail Message "In the Light of Truth" is recommended for a comprehensive explanation of the world based on the laws of creation, which allows the reader to recognize the hidden connections in life and thus offers valuable life support.
